**PREAMBLE:**

On one hand, Dr. Enrique Luis Graue Wiechers, Rector of Universidad Nacional Autónoma de México, on behalf and legal representation of it, according to the provisions of Article 9<sup>th</sup> of the Organic Law and 30<sup>th</sup> of the General Statute.

And on the other hand, Prof. Dr. Joybrato Mukherjee, President of University of Justus Liebig Universität Gießen, on behalf and legal representation of it, according to the provision of the Higher Education Act "Hochschulgesetz" (§ 44 Section 1, clause 1, HessHG).

**DECLARE:**

That both Parties recognize each other's legal personality and the one of their representatives.

That both Parties confirm the terms and scope of the General Agreement of Collaboration signed on April 2, 2018, which is valid for 5 (five) years, hereinafter referred to as "**THE GENERAL AGREEMENT**".

That both Parties confirm that their legal addresses are those indicated in "**THE GENERAL AGREEMENT**".

That both Parties hold this Extension Agreement under the same terms and scope of "**THE GENERAL AGREEMENT**".

That it is their will to celebrate the present Extension Agreement to keep fostering collaboration between "**THE PARTIES**", to undertake joint academic, scientific and cultural activities, in areas of common interest.
