Welcome to the International PhD Programme "Literary and Cultural Studies" (IPP) at Justus-Liebig University, Giessen (JLU). This handbook is designed as a guide to the programme, its curriculum, activities, and the wide range of opportunities on offer to its members.

Founded in 2002, the IPP was initially funded by the German Academic Exchange Service (DAAD) and since 2007, after the expiry of the maximum DAAD funding period, it has been financed by the JLU itself. An integral part of the Giessen Graduate School for the Humanities (GGK), the programme collaborates closely with the International Graduate Centre for the Study of Culture (GCSC) and the European PhDnet "Literary and Cultural Studies", and contributes decisively to postgraduate education at the JLU.

The IPP provides a clearly structured and research-oriented three-year doctoral programme with a strong international focus. Its curriculum is designed to ensure the academic quality of the PhD while at the same time facilitating its completion within three years. Regular doctoral colloquia give the opportunity for researchers to present their works in progress once each semester, and to receive feedback from affiliated professors, the IPP coordinator, and their fellow IPP members. This is supplemented by core courses on planning, developing and completing the PhD, as well as regular lectures, seminars, workshops and master classes with renowned scholars in the fields of literary and cultural studies.

Moreover, there are manifold opportunities to gain additional academic and professional experience and qualifications. The IPP is involved in, and often co-organises, a wide range of conferences and summer schools in partnership with an expansive international network of high-ranking universities and institutions from around the world, frequently leading to publishing opportunities for participants. In addition, the IPP can provide funding for a range of programmes and academic events, including German-language courses at the JLU, conferences and/or research trips as well as editorial support once the thesis is completed and might be in need of proofreading by a native speaker.

More detailed information can be found in this handbook, along with useful information on many of the important aspects of life and study as a member of the IPP on the path to a successful and rewarding doctoral experience, and the foundations for a career as an academic engaged in a lively and stimulating international scholarly community.

We wish you all the best for your academic life in Giessen!

# **Colloquium Guidelines**

The doctoral colloquium is at the heart of the IPP. Every three or four weeks, each cohort meets for two or three presentations and discussions of work in progress. Each member of the IPP presents once a semester and receives feedback from the professors, the IPP coordinator, and fellow IPP members. Each presentation and discussion is one hour in total. A detailed semester-by-semester plan follows this section. However, there are certain staple features of the colloquia.



#### Materials for Circulation

The basis of the presentations and discussions is the material circulated by the presenter; some requirements change from semester to semester (see the section below) but, in general, the materials required are the following: the current outline/table of contents, a sample of work in progress, a list of the key questions or problems the presenter is currently facing, and a full working bibliography. Of special importance are the problems the presenters have to deal with or the key questions they aim to find answers to, because it is through the problems raised and the questions asked that a constructive discussion of projects can be initiated. Also: please, remember to paginate your text to facilitate the discussion.

You should send any material you would like to distribute among the participants of the colloquium by Tuesday the week before your presentation to the mailing list of your year-group (provided by the IPP at the beginning of each semester). The timely submission of these materials is crucial for the smooth running of your colloquium since it assures that all participants will be able to prepare adequately and give feedback on your work in progress.

#### **Presentations**



Each of the sessions contains two or three one-hour slots for each presenter, including the time for the presentation and the discussion. The presentation should be based on the materials circulated among the IPP members and staff. Presentations are expected to be around 15-20 minutes; nevertheless, they tend to become shorter as the group becomes more acquainted with the projects (the longer the presentation, the less time for discussion). Discussions usually follow a pattern of focusing first on the title, then on the outline, and finally on the written sample circulated and any issues currently addressed and problems to be solved.

# Respondent Role

From the beginning of the first year (Semester 2) presenters are designated with a fellow IPP member as their 'respondent'. The purpose is to facilitate a productive discussion and constructive engagement among members' projects: the respondent is asked to carefully consider the materials circulated by the presenter, and to prepare a written response, which should be circulated by the respondent a day prior to the session. After the presenter clarifies or expands on the issues raised by the response, the discussion is opened up to all participants.

A response might include a recapitulation (very briefly) of what appear to be the materials' key points or arguments; comments and questions on the project's outline/table of contents, followed by a response to the text itself and the bibliography, including an attempt to address any questions/problems identified by the presenter in the circulated materials; and a conclusion with two or three specific questions addressing central points of the project.

#### Minutes (Protokoll)

Members of the colloquium are asked to take the minutes of the discussion of the presentations (though not the presentations themselves) in turns. The purpose of the minutes is to make it easier afterwards for the presenter to work through what has been discussed in the colloquium by having the most important results of the discussion in written form. The minutes should not be verbatim reproductions, but rather capture the essential points and questions raised. The minutes may include the name of the person who raises the question or point. The responses of the presenter should also be recorded.

The minutes should be as objective as possible, neither selecting nor evaluating the points or questions raised. When the title of a book or article is mentioned during the discussion, the title should be given in the minutes **together with bibliographical information**. Minutes should be sent to the IPP cohort mailing list **within a week of the colloquium**.

#### **Curriculum and Semester Plan**

The table below will give you an overall view of the IPP curriculum and the courses offered by the IPP and its affiliated programmes. Detailed semester-by-semester information on the course requirements follows the table.

# Colloquium



Materials to circulate: Summary introduction to the project, outlining the area of research, and including:

- Three primary goals
- At least three key questions
- The key concepts used in the study
- Methods and approach
- Problems and issues
- Preliminary table of contents
- Full working bibliography

Presentation: 15-20-minute spoken introduction, drawing on the materials circulated. Powerpoint is advised, though not compulsory. Please inform the IPP team of any required equipment or technical assistance ahead of time (laptop, beamer, speakers, etc.).

Materials to circulate: Summary progress report on the project, responding to or incorporating feedback from the first colloquium presentation, providing all the same components as in the first semester (see above) and additionally including:

- Proposed primary corpus
- Revised outline/table of contents
- Clear conception of the chosen methods

Presentation: as in Semester 1

Respondent role: In Semester 2, designated IPP members respond to one another's work in progress. Please see the section on the respondent role.

- Participation in at least one of the GGK Sections or a GCSC Research Area

#### Colloquium

Materials to circulate (around 15 pages in total):

- Up-to-date table of contents/outline, highlighting any changes made
- List of current problems/issues
- 10-page text of work in progress or most suitable for discussion (i.e., chapter extract). It is recommended that in either Semester 3 or 4, you submit a provisional "Introduction"
- Full, extended working bibliography (not included in the page count).

Presentation: As in Semesters 1 and 2, with an explanation of changes made to general outline, elaboration of current problems, and contextualising information on the place of the writing sample in the dissertation as a whole.

Respondent role: As in Semester 2. Please see the section on the Respondent Role.

# Obligatory courses and activities

- Intermediate course/Aufbaukurs
- One workshop and/or master class
- Participation in at least one of the GGK Sections or a GCSC Research Area

### **Voluntary courses**

As in previous semesters

#### Necessary official procedures

- Hand in a copy of your official letter of acceptance as doctoral student (Annahme als Doktorand/in) at the JLU (issued by the Academic Examinations Office/Akademisches Prüfungsamt) to the IPP or contact the IPP to let us know the stage you are at.
- Ensure that you have a second supervisor/examiner in place by this stage.



#### Colloquium

Materials to circulate: As in Semester 3, with a 10-15-page new chapter/sub-chapter (or extract) in progress.

Presentation: As in previous semesters. Because it is expected that as the colloquium becomes acquainted with the group's projects, presentations are likely to become shorter, without requiring substantial introduction to the project as a whole, but rather to significant changes, or current problems/issues.

Respondent role: As in Semester 2. Please see the section on the Respondent Role.

# Obligatory courses and activities

- Participation in at least one of the GGK Sections or a GCSC Research Area

#### Colloquium

Materials to circulate: As in Semesters 3 and 4, with a 10-15-page new chapter/sub-chapter (or extract) in progress.

Presentation: As in Semesters 3 and 4.

Respondent role: As previously. Please see the section on the Respondent Role.

# Obligatory courses and activities

- As previously, though it is expected that in the final year of the PhD, researchers will reduce participation in master classes, seminars, etc., as they move into the *Endphase*.
- Participation in the PhD Defence Course (*Disputationskurs*) either in this semester, or in Semester 6, depending on availability.

## Necessary official procedures

• Apply for permission to be admitted for the award of PhD (Antrag auf Zulassung zur Promotion) at the Academic Examinations Office (Akademisches Prüfungsamt) at least six months before submission of the dissertation. There is a fee of €100, though exemption may be possible on formal request.



*Please note:* Although participation in the colloquium in Semester 6 remains compulsory, circulating materials and giving a presentation is **voluntary**, to allow researchers to focus on their final writing stages when necessary.

#### Colloquium

#### Materials to circulate:

- As in previous semesters, but with the current table of contents, indicating which chapters/sub-chapters have been completed (marked with an 'A'); those that are near completion (marked with a 'B'); and those yet to be written (marked with a 'C').
- A 10-15-page new chapter/sub-chapter (or extract) in progress.

Presentation: As in previous semesters

# Obligatory courses and activities

• Participation in the PhD Defence Course (*Disputationskurs*), if not taken in the previous semester.



# Necessary Official Procedures (General Information)

- Gain approval for your commission for the defence, by writing a letter to the current Dean of the Faculty of Humanities, the IPP can provide you a template letter for this purpose. Your commission should include 5 examiners, as follows:
  - o The current Dean or an authorised representative;
  - Your first supervisor;
  - Your second supervisor:
  - Two 'fachfremde' examiners (i.e., examiners drawn from other disciplines, though they may come from the JLU). If the Dean is already fachfremd, one of these two other examiners is allowed to be from your own discipline.
- In case you have an external second supervisor (outside the JLU), please contact the IPP team before arranging your defence.
- Once the *Zulassung zur Promotion* (see above) has been confirmed, it is possible to submit the dissertation (six bound copies) to the *Akademisches Prüfungsamt*. The *Prüfungsamt* will send a copy each to your supervisor and second supervisor, who will need to write an assessment (*Gutachten*) of the dissertation to submit to the *Prüfungsamt*. It can accelerate the process if you print and send on copies of your dissertation personally to your supervisors.
- Please hand in an additional copy of your dissertation to the IPP (either in print or in an electronic form).
- Once the assessments have been received by the *Prüfungsamt* and your Commission has been authorised, the *Auslage der Dissertation* starts. It is the period in which the dissertation is held at the Examinations Office where it may be read by any active professors at the university. The period lasts for two weeks within term-time, or one month if the period includes a semester break.
- The Defence can be arranged within the *Auslage* period, for any time after the *Auslage* is completed.
- Please inform the IPP of the date of your defence and the final title of your dissertation.
- Please bear in mind that, when it comes to the official procedures regarding submission of your thesis and defence, these guidelines are there for your orientation. Near the start of the submission process, you will have to get in touch with the Akademisches Prüfungsamt that will be able to provide you with the current information and guide you through the process of submission and defence.



Sections are part of the programme of the Giessen Graduate Centre for the Humanities (GGK). They are bottom-up foundations of postgraduate students who work in the field of literary and cultural studies and are subject to change according to the researchers' interests. The GGK's sections serve as forums where young scholars – doctoral candidates, post-docs, and other students at an advanced level of study – can present their research projects and collaborate on fundamental, interdisciplinary questions. Members can, for example, make use of the administrative and financial support of the GGK to arrange for guest speakers and conferences on salient topics, or to prepare research done in sections for publication. New members are of course welcome to join at any time, or to visit a meeting as guests. Simply get in touch with the section's contact person via email.

In addition to GGK sections, **Working Groups** (Arbeitsgruppen or AGs) are also active forums for scholarly exchange. Participation is not obligatory but encouraged. Working Groups are hybrid structures that collaborate with other parts of the graduate centre. An AG can serve as a forum for handling a topic.

# Teaching Undergraduate Courses at the Departments

#### The International Graduate Centre for the Study of Culture (GCSC)

The International Graduate Centre for the Study of Culture is a 3-year doctoral programme in the study of culture that aims to establish optimum conditions for postgraduate students in the Faculties of History and Cultural Studies, Social Sciences and Cultural Studies as well as Language, Literature and Culture.

#### Centre for Media and Interactivity (ZMI)

The Centre for Media and Interactivity is involved in research on questions concerning media. It focuses on the concept of interactivity and the diverse effects of interactive digital media in society, politics, economics, culture and science. The ZMI researches projects, tests interactive platforms, holds conferences and workshops, and edits publications such as the book series 'Interaktiva' with the Campus Verlag.


#### Centre for Eastern-European Studies (GiZo)

The Centre for Eastern-European Studies was founded in July 2006 and organises research and teaching in the humanities on the countries of Eastern Europe. The GiZo profile profits from a strong university tradition of Eastern European research in cultural, political, social sciences, economics, law and agricultural sciences. The centre is based on a regional concept of 'Eastern Europe', which is taken to include Turkey and the Turkic-speaking regions of the former Soviet Union, as well as Central Eastern, South-Eastern and Eastern Europe. Building on this concept, the GiZo seeks to describe, analyse and evaluate Eastern Europe within the context of Europe as a whole.



#### International Networks

IPP members benefit from the programme's well-established international networks with top-level research institutions around the world. The IPP participates in four multi-lateral networks (Lisbon Consortium, ESSCS, Hermes and PhDnet) and numerous bilateral collaborations. These networks promote lively exchange between doctoral students and junior as well as senior scholars world-wide, thus integrating IPP members into the international academic community. The IPP cooperates closely with the GCSC in the systematic development and expansion of international collaborations with top-ranking universities.



The internationalisation of postgraduate studies is one of the IPP's key policies and opens up a broad spectrum of opportunities to our members, from cooperation on conferences, to master classes, to the possibility of exchange with doctoral researchers at other institutions. Moreover, we encourage international co-supervision of PhD-projects ('Cotutelle') when this is of clear benefit to a specific project.

The Lisbon Summer School for the Study of Culture is the annual meeting of the Lisbon Consortium's MA and PhD Program in Culture Studies, bringing together leading scholars in the field of culture and doctoral students and researchers from all around the world.

# European PhDnet "Literary and Cultural Studies"

IPP members can participate in the European PhDnet "Literary and Cultural Studies" thus pursuing their doctoral studies at the JLU Giessen and one of the four partner institutions, where their projects are jointly supervised within a 'Cotutelle' framework. They are awarded bi-national degrees. Applications are accepted every three years, at the beginning of each new cycle. The five European partner institutions are:

# **Services for IPP Members**

**Conference Experience and Travel Grants** 



Annual summer schools and conferences in the stimulating atmosphere of the beautiful castle of Rauischholzhausen (Giessen), as well as at partner institutions, promise intense academic discussions and help in forming life-long friendships with peers from all over the world. The IPP offers Summer School Coaching sessions for members preparing to deliver what may well be their first academic paper.

Any official IPP member can apply for a travel-expenses claim for conferences, summer schools and research trips. In order to receive financial support for such academic events, you must either present a paper or be involved in organizing the event. However, exceptions may be negotiated on a case-to-case basis.

Reimbursements may be claimed for the following expenses:

- travel tickets (including public transportation)
- conference fees
- accommodation costs
- Visa fees

Please note that original receipts must be provided for all claims. Journeys by train will generally be reimbursed at the rate of second-class travel (the most economic option). The purchase of a discount card (*BahnCard 25, 50*) is strongly suggested.

In order to ensure the smooth processing of your application, please bear the following points in mind:

- 1. Always favour the most economic, that is, the most cost-saving travel option (even if this means you may not have a direct flight, for example). As the prices for flights tend to vary considerably, please check with the IPP coordinator (when in doubt) if the price is reasonable before you make your application.
- Hand in your application well in advance (at least six weeks earlier) and before making any reservations. Otherwise, there might not be enough time for the IPP to assess your application. Check our website for the Travel Claim Form in the "Financial Support" Section.
- 3. Please bear in mind that once the travel claim has been approved, we cannot reimburse any further costs (e.g., if the flight tickets get more expensive than you estimated).
- 4. The IPP does not cover memberships to academic associations.

The IPP director and coordinator will examine each application with care and will make their decision with reference to the following criteria for support:

- academic quality
- relevance of the event or travel for your research project



- the IPP's goal of furthering doctoral students' experience and skills in presenting and publishing papers
- the IPP's goal of establishing and maintaining international networks through its members' active engagement in international events, conferences and research trips.

In order to apply, please fill in the Travel Claim Form, which can be downloaded from the GGK/GCSC webpage following  $Support \rightarrow Financial\ Support \rightarrow Travel\ Grants:\ IPP.$  Please note that in order to receive the reimbursement, you are required to submit a written report on your conference/summer school trip or research stay to the IPP coordinator within four weeks of your return.

# Native Speaker Editorial Support

The IPP offers editorial support for those programme members who write their dissertation in a language other than their mother tongue.

If you are a native speaker of German writing your dissertation in English or in the language of your academic discipline (except German), or if you are a native speaker of a language other than German writing your dissertation in German or in the language of your academic discipline (except your mother tongue), you are eligible to apply for editorial support by a native speaker to proof-read your thesis.

#### Applications must include

- a letter of motivation with detailed outline of the necessity of the native speaker editorial support including estimated costs of this support
- an outline of the dissertation project and select bibliography
- a letter by the first supervisor to support the necessity of the native speaker editorial assistance including statement on the applicant's progress
- the designated editor's name and address

Applications will be accepted throughout the academic year. Bear in mind that applications can only be considered if they are submitted to the IPP (a) prior to the proofreading process, and (b) well in advance so that the IPP has enough time to review and decide about them.

If your application is successful, you will receive a one-time payment of up to €500 to be used towards the actual costs for editorial support.

#### **Publishing Opportunities**

Several volumes of collected essays on seminal topics in literary and cultural studies have emanated from the IPP, bringing together contributions from renowned scholars and PhD



students. There are particularly close links with two publishers: Wissenschaftlicher Verlag Trier (WVT) and De Gruyter (Berlin and New York).

The conferences and symposia co-organized by the IPP often result in conference proceedings. Postgraduate students' contributions are usually considered for publication in these proceedings and thus offer IPP members many opportunities to gain their first academic publications.

Further publishing opportunities are provided by the GGK online journal *KULT\_online* (https://journals.ub.uni-giessen.de/kult-online/) which invites PhD students to write reviews on recent publications and the GCSC peer-review online journal *On\_Culture*: *The Open Journal for the Study of Culture* (https://www.on-culture.org/). *On\_Culture* is a biannual, peer-reviewed academic e-Journal created and edited by doctoral researchers, postdocs and professors working at the GCSC. The journal offers numerous opportunities to contribute: calls for abstracts released biannually seek contributors of peer-reviewed academic articles, essay. Perspectives pertaining to all issue topics are welcome at any time.

Accompanying courses in academic writing will also provide excellent supervision and help to acquire expertise in the various academic genres that should be part of a convincing publishing portfolio.

# The IPP Library

The IPP library is located in the GGK/GCSC building (Room 120) and holds a collection of relevant books from the field of Literary and Cultural Studies, including the complete ELCH-series, as well as works of reference and handbooks. The list of the books can be found on our website following  $IPP \rightarrow Support$  for Members.



To ensure an optimal availability of our stock to all IPP members, books may only be borrowed for a limited period. The regular loan is one month. Before expiration of the time limit, you can extend the deadline for a second month by e-mailing <a href="ipp@uni-giessen.de">ipp@uni-giessen.de</a>.

We also encourage you to suggest publications for acquisition to the *Universitätsbibliothek*.





# **German Language Courses**

Although learning German might not look like a 'must' at the beginning of your studies, it will in due course prove to be quite useful, not only because it will make daily life in Germany easier – and, of course, more enjoyable – but also because it is always good to be prepared for German-language situations in academia.

At the same time, keep in mind that you will be required to obtain <u>at least</u> a **B1** German proficiency level before your defence, according to faculty regulations.

Every semester, the International Office (*Akademisches Auslandsamt*) offers German language courses to those members who plan to improve their skills. Within each course, there are 4 hours of instruction per week, catering to various levels of language competence. Doctoral students are required to pay a nominal fee for these classes: in the Winter Semester, about €175, and in the Summer Semester about €158. The IPP can, however, reimburse these costs (please retain receipts).

Classes run from October to February and from April to July (i.e. during the academic semester) in the evenings – as a rule, on Tuesdays and Thursdays, 18:15–19:45 (each class lasting for 90 minutes or, in German, a *Doppelstunde* or 'double hour'). Admission to the courses is based on a test at the start of the semester.
